

12 Things You Should Know About COVID-19 Vaccines

1. COVID VACCINES DO NOT PREVENT INFECTION OR TRANSMISSION

COVID vaccines do not prevent infection or transmission of COVID-19. Their purported benefit is they reduce symptoms. This means the vaccines are treatments and not vaccines.

[CDC definition of vaccine prior to August 26 2021](#): *A product that stimulates a person's immune system to produce immunity to a specific disease, protecting the person from that disease.*

CDC definition of vaccine days after the FDA gave final approval to Pfizer's mRNA shot: *A preparation that is used to stimulate the body's immune response against diseases.*

2. COVID VACCINES UTILIZE mRNA TECHNOLOGY

3. COVID VACCINES WERE ADMINISTERED WHILE STILL EXPERIMENTAL

The COVID vaccines were authorized and administered for use while the product was classified as experimental. How many Canadians understood that they were subject in Phase III human trials?

The Public Health Agency of Canada (PHAC) authorized COVID-19 vaccines under an [Interim Order](#) which enables the widespread deployment of the vaccines while the Phase 3 clinical studies (experiments in people) are being conducted.

4. SERIOUS ADVERSE VACCINE REACTIONS ARE REAL AND ARE UNDERREPORTED

The US Vaccine Adverse Events Reporting System reports 1.2M adverse events (AE) following COVID shots including 26, 693 deaths as of April 1, 2022. Less than 1% of adverse reactions are reported to VAERS. Pfizer's recently released clinical data reported 1,291 different adverse reactions, that 15,000 study subjects suffered serious neurological disorders, and they planned to hire an additional 1800 staff to field incoming calls of injuries. 5. **LACK OF INFORMED CONSENT**

Data reveals that these shots have only short-term efficacy, that the spike proteins produced with mRNA vaccines can damage organs and cells, and that the injections do not prevent infection. 6. **VACCINE MAKERS ARE IMMUNE FROM LIABILITY**
