Dear VCC Community,

A colleague that I haven't spoken with in more than

two years reached out this week. When we last spoke and I explained the work I was doing for VCC in protecting our right to informed consent, he responded with – *“I can’t go there with you. I follow the science.”* Given this was our last encounter, I entered the conversation with trepidation.

While no apology was issued, he did acknowledge that I must be disappointed with the lack of support of my colleagues. He also acknowledged that the world has become very divided over the last two years. He recalled his experience in visiting places in recent history where genocides and mass murder against former friends and neighbours have occurred – Cambodia, Rwanda, and Auschwitz. He sees the similarities to today.

We talked about evil and the fall of humanity during these last years. And while the conversation was dark and disturbing, he ended on a hopeful note. He said – *“I subscribe to the idea that humanity is like rough rocks that become polished by the friction between us. I believe these past three years are part of humanity’s transformation.”*

On that we agree. I too see signs of hope, of transformation, and of deepening wisdom. This

renewed relationship is but one example of that. They say it is darkest before the dawn. Stay hopeful! Stay positive! Shine your light! Truth will prevail!

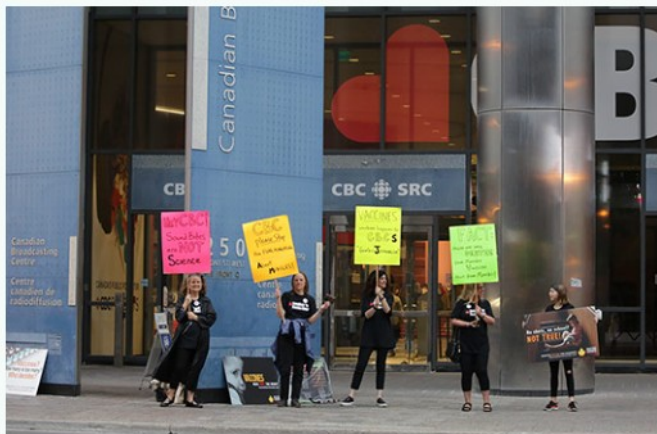

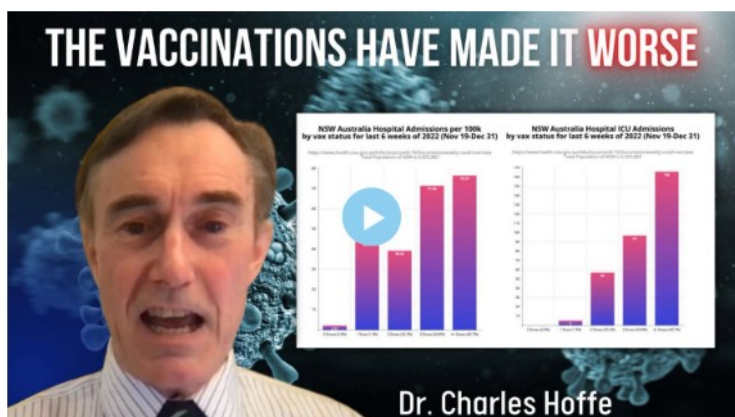

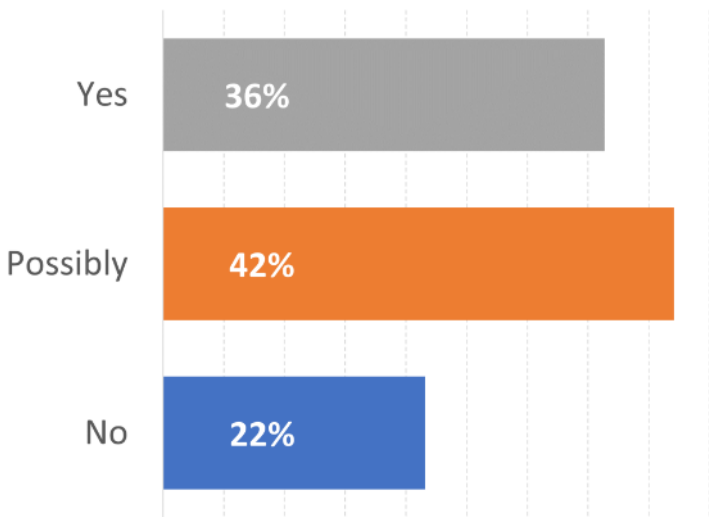

support. This is our soul purpose. Our family needs us and we are building a self-reliant life style so we can support them all if need be!

- Nothing is guaranteed. Although Alberta seems like to place to be right now, I have a good community and church that I want to continue with. Our church is very active in pursuing ways to make changes from within the system such as school board positions etc., to make changes. We realize this will not happen overnight but we need to unite from all over Canada to accomplish gain for our God given human rights.

With a nefarious government in Ottawa, it is nowhere save to live. All provinces are bribed into complacency by Castro, in the hands of the WEF, bathing in their power received by complete overreach, treating the people with utter disdain.

- If I move from BC, I would likely move out of the country but until last night (Tues Jan 10), I had not considered that possibility

- No, I will not move to Alberta. I love where I live. We must stand up against this tyranny and take back our God-given rights and rebuild our communities starting at the local level. It can be done!
- One may think the grass is greener on the other side. However, who knows. Will Daniel Smith get voted in in the next election? I sure hope so, but who knows. The powers that be could manipulate things, who knows in this time of no accountability and transparency. If everyone moves out of Ontario who is going to be left to fight back.

Thoughts of those who chose Possibly

- You can't guarantee that there will always be a like-minded premier in office.
- I am old and I am tired. Regardless, if the screws tighten, nothing could be worse to die anywhere else but in a place of freedom. May Alberta thrive in freedom under sane and thoughtful leadership.
There are SO many factors to consider regarding a major move, and no guarantee that events won't be orchestrated (false flag operation or otherwise) to thwart any justice achieved by Premier Smith. Still, if there are huge numbers of awake people thriving and

supporting each other in Alberta, there's always a possibility I may feel compelled to move, as much as

- I'd miss BC, if things become unbearably untenable here.

Of course living in a province that respects our human rights is the biggest draw of all, but it's going to be a hard sell convincing the whole gang to pick up and move, and I am not going anywhere unless my kids go too.

- We have no choice!

- Currently living in BC. Was a HCW until terminated in Nov. 2021. Now I'm Alberta bound.
- As a single senior life in BC is becoming unmanageable. I have lived and worked in Alberta twice in my life for a few years but didn't think I would be returning – out of necessity, not choice.


