My trip back to Canada this week gave me the opportunity to listen to much of the testimony at the National Citizens Inquiry in Toronto. The testimony was disturbing to say the least. Our country has been captured by an agenda that is beyond devious.

Mary Holland, President of Children's Health Defence, describes the last three years in her article – *Courts Follow Culture*.
