Medical Tyranny in Canada – They are Coming to Inject Our Children with COVID-19 Shots

It is incredibly difficult to fathom the depth of what's behind the stated intention of governments to inject every human on the planet with experimental gene therapies developed in response to COVID-19. Even more puzzling is that normally thoughtful people are allowing themselves and their children to be coerced into taking experimental high-risk injections. We are witnessing a global dearth of rational thought and evidence-based decision making, and an almost eager participation in obediently giving up our inherent rights and freedoms. Is humanity under a spell?

COVID measures and COVID-19 injections (termed 'clot shots' by physicians who treat this documented injury) have harmed and killed hundreds of thousands of people – while the COVID 'pandemic' hasn't resulted in significantly more deaths than those of recent years. The illusion that our government, public health, and the conventional medical system have our best interests at heart has been smashed beyond all repair. The fraud has been exposed.

This callous disregard for risk and the barbarous attack on our inherent rights and freedoms is particularly evident in recent government announcements to make the experimental COVID-19 injections available to children ages 5 – 11 years, which will be in addition, of course, to an already bulging-at-the-seams childhood vaccination schedule. On that schedule, Canada's children receive 68 or 70 doses of 16 or 17 vaccines by age 18, depending on province/territory. If you are 35 years of age or older, you've received fewer vaccines in your life than a six-month old baby today.

Covid survival rate for all ages is ~99.85%. **The overall survival rate of minors (under the age of 19 years) with COVID-19 is 99.997%.** It has been established that children do not contribute to the transmission of COVID illness.

Despite this, governments are now accepting registration for children ages 5 – 11 years, seemingly oblivious to the extreme risk and zero benefit of the shots, and regardless of the fact that Health Canada has not yet approved a COVID-19 shot for this age group.² Health Canada approval does not mean these products or any vaccines are safe, effective, or necessary. COVID-19 shot trials are underway on six-month-old babies. This

targeted marketing of our children will add significantly to the billions of dollars in profits for the liability-free pharmaceutical industry.

In preparation for injecting children ages 5 – 11 years with COVID-19 shots, governments have made changes to long standing risk management requirements that will increase the risk to children. For example, the BC Government has removed the requirement to consult with a Program Manager or Risk Management Consultant for further direction when obtaining mature minor consent from children 12 years of age and younger.¹ The justification given is that *“This change has been made to remove any perceived barriers for such children who are deemed capable and wish to provide consent on their own behalf”* (i.e., mature minor consent).

Children as young as nine years old are being vaccinated in the school setting without the knowledge or consent of their parents. Implying that children as young as five years of age could be deemed capable of providing consent to receive these experimental products is unconscionable, irrational, and completely unethical.

Subjecting our children to COVID-19 injections upon our children is not a decision which is based on medical or scientific evidence. Mandated or coerced compliance to injections defies the medical industry’s own four main principles of ethics: Autonomy, Beneficence, Non-Maleficence, Justice.

THE FACTS

1. The Safety Testing of All Childhood Vaccines and COVID-19 Shots is Sub-Standard

No childhood vaccine product licensed for use in Canada or the USA has been tested using the long-term, double-blind, placebo-controlled studies required for all other pharmaceutical products. Instead, the medical industry uses the monitoring of adverse events following vaccination as the primary method to evaluate product safety.

All vaccines, by design, force the immune system to respond with inflammation. That inflammation then triggers the brain’s own immune cells (microglia) to secrete highly toxic chemicals that lead to a chronically inflamed state in the brain, destruction of connective synapses, seizures, and brain injury. Known severe risks specific to the experimental COVID-19 injections include brain swelling, paralysis, convulsions and seizures, stroke, narcolepsy, shock, heart attack, autoimmune disease, arthritis, joint pain, blood clots, multisystem inflammatory syndrome in children, cancer, neurological injury and death. Life-threatening effects, such as blood clots and myocarditis, have been reported specifically in young people.

2. Canadian Government and Public Health Policies are Not Lawful

Medical procedures and/or treatments are defined as any that affect one’s health, whether physically or psychologically. Treatment without prior, expressed, informed consent is assault. Consent cannot be implied.

Those who **coerce or mandate compliance** to medical procedures including masking, vaccination, or testing and enforce lockdowns are unlawful and **subject to criminal charges**. Government and public health orders violate Canada’s Charter Rights & Freedoms. Our innate rights are protected under Common Law, Statutes, and the Charter of Rights and Freedoms, as dictated by the Supreme Court of Canada.

3. COVID-19 Injections - High Risk of Life-long Injury/Death

In a Federal Court legal action initiated by America's Frontline Doctors, a U.S. Government Whistleblower with expertise in healthcare data analytics employing CMS Medicare & Medicaid data, submitted a sworn statement under penalty of perjury. She claims to have incontestable evidence that the actual number of COVID vaccine deaths within 72 hours of vaccination approximates 45,000. Since this number of deaths is from only one (1) of twelve (12) reporting systems in the U.S., if accepted as an average, this translates into 540,000 deaths.

Some COVID-19 injections carry the risk of a rare blood clotting disorder "Vaccine- induced Immune Thrombotic Thrombocytopenia" (VITT). It is possible and plausible that this reaction could be a class effect caused by spike proteins induced by all current COVID-19 injections. There is a risk that Covid-19 injections may worsen clinical disease due to antibody-dependent enhancement (ADE), which has been observed in animal trials during previous attempts at developing a mRNA vaccine against Coronavirus.

Scientists have raised multiple concerns regarding possible short and long-term adverse effects, specifically relating to the spike protein. Covid-19 injections introduce a synthetic gene which induces the recipient's own cells to produce viral spike proteins with no way of knowing if this process will ever end. Spike proteins appear to contribute significantly to the pathogenicity of SARS-CoV-2, and there are studies suggesting that they have the potential to cause pathology on their own.

It is totally unknown how much spike protein will be produced by an individual and as indicated above, for how long. Young healthy people may produce higher quantities, thus potentially increasing the risk of side-effects.

An escalating number of reports of myocarditis are reported to health authorities, especially in teenagers and young male adults, following the mRNA Covid-19 injections.⁴

The risk of myocarditis following Covid-19 injections seems to be 30-200x the normal background risk, as shown in a recent presentation by the US CDC's Advisory Committee on Immunization Practices (ACIP). Myocarditis carries a long-term risk of heart failure, and may also require restricted exercise and medication for several months after recovery.

4. Canada's Public Health System – Complicit in a Catastrophic Epidemic of Chronic Illness

We are in serious peril in Canada as we experience an epidemic of chronic illness, especially in children. This is the sad reality for many thousands of families, a situation well established before the COVID 'pandemic' – a pandemic where contagion has not been proven and that has not resulted in a significant increase in deaths over those of preceding years.

Canadian public health fails to educate the public on reliable dietary advice that is at the core of healthy immunity to the complications of illness. At every turn, the official government and public health narrative centers nutritional advice that is in fact health-robbing, dependency on the use of pharmaceutical products and allopathic interventions, synthetic supplements, pharmaceutical medications, and vaccines which are proven to contain toxic chemicals and a plethora of health damaging ingredients including aluminum and other metal nanoparticles.³

This great failing by our government, public health, and the conventional medical system has resulted in an epidemic of chronic disease, especially in children. Two gifts of wisdom from Hippocrates to humanity and

medical professionals are **first do no harm** and **all health begins in the gut**. How is it that iatrogenic death in the conventional system has become a top killer of Canadians, and how is it that official medical and dietary advice from Canadian public health is implicated in the unprecedented epidemic rates of cancer, diabetes, autism, allergies, asthma, arthritis, heart disease, cognitive impairment, chronic ear/chest infections, infertility and more?

The number of Canadian children falling on the autism spectrum was about one child in 10,000 in the 1980's, today's rate is approximately one child in 36 children, and this exponential rate is predicted to be 80% of the boys and half of the girls born in the coming years – even without accounting for the additional harm of the new experimental, DNA/RNA altering therapeutic COVID-19 injections.

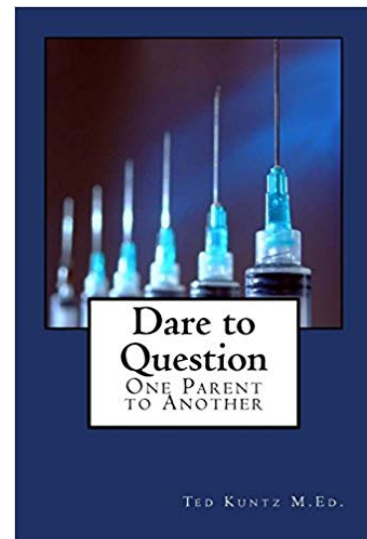

Vitamin A is our number one protection against disease. The immune system cannot function without vitamin A. Two important points about vitamin A: First, we cannot get adequate vitamin A by converting the carotenes in fruits and vegetables into the true vitamin A. Secondly, vitamin A requires vitamins D and K2 as cofactors. Foods that provide us with vitamin A, usually also contain vitamins D and K2—foods like butter from grass-fed cows, egg yolks from pastured chickens, aged natural cheese, shellfish and organ meats like liver. In addition to these foods, cod liver oil can provide vitamins A and D on a daily basis.
