

Top 10 Things You Should Know About COVID-19 Shots

1 VACCINE MAKERS ARE IMMUNE FROM LIABILITY

Vaccine manufacturers have no incentive to ensure their vaccines are as safe as possible. COVID-19 vaccine manufacturers cannot be sued if their vaccines cause death or harm. The Canadian government has granted them indemnity.

2 VACCINE COMPANIES HAVE LONG RAP SHEETS

Pharmaceutical corporations have paid out tens of billions of dollars for crimes, including fraud and violating the US False Claims Act, when they marketed products while knowing they would cause injuries and death (ie: Vioxx, Opioids).

With this history, what incentive exists to prevent the sale of injurious vaccines, especially when the Canadian government has given the manufacturers protection from any liability for injury and death caused by the rushed and inadequately tested COVID-19 shots?

3 PREVIOUS ATTEMPTS TO MAKE SIMILAR VACCINES HAVE FAILED

In one study, vaccinated infants got much sicker than the unvaccinated infants when exposed to the respiratory syncytial virus (RSV) naturally, with 80% of the vaccinated infants requiring hospitalization. Two died. In subsequent studies, vaccinated animals became very sick when they later became infected with the actual virus. Many died. This phenomenon is called Pathogenic Priming or Antibody Dependent Enhancement (ADE).

4 COVID VACCINES HAVE NO LONG-TERM SAFETY STUDIES

There is no way to determine what these experimental vaccines will do to humans in the medium-to long-term. Not all vaccine injuries manifest immediately. Health Canada has only provided Interim Approval to COVID vaccines since Phase 3 studies will not be complete until 2022 and 2023.

5 SERIOUS ADVERSE VACCINE REACTIONS ARE REAL AND ARE UNDER-REPORTED

As of April 23, 2021, 118,902 adverse events following COVID-19 vaccination have been reported to VAERS, including 3,544 deaths. As of April 23, 2021, Canada has reported 4128 vaccine related adverse reactions including 19 deaths which are under investigation. According to a government-funded study at Harvard, less than 1% of all adverse reactions to vaccines are actually submitted to the National Vaccine Adverse Events Reports System (VAERS). No similar study has been done in Canada.

6 COVID VACCINES HAVE NOT BEEN PROVEN TO STOP INFECTION OR TRANSMISSION

The clinical trial designs for COVID vaccines did not address transmission, but merely addressed reducing symptoms, as explained in the materials they submitted to the FDA to obtain Emergency Use Authorization.
