



STOP the EXPERIMENT - References & Further Information

1) Serious adverse reactions, including life-long injury, disability and death are real and are under-reported.

Vaccine Adverse Events Reporting System (VAERS): 118,902 adverse events following COVID-19 vaccination; 3544 deaths through April 23, 2021. Less than 1% of all vaccine adverse reactions are reported.

2) Safety trials will not be complete until 2022/2023. COVID shots are human experimentation.

The Nuremberg Code prohibits experimenting on humans without fully informed consent. Pharmaceutical manufacturers of COVID shots have legal immunity for any harm or injury caused by their products.[1]

3) COVID shots may cause infertility, miscarriages, and birth defects.

COVID shots use the cell's own machinery to create a protein that is identical to the spike protein on the coronavirus. This same protein is also found in the placenta and in sperm. There is significant concern that the immune response initiated by the vaccine will prevent placentas and sperm from forming properly.

4) COVID shots use genetic technology and may affect all future generations.

COVID shots are a medical device that includes never before used synthetic genetic technology based on a computer generated "*spike glycoprotein antigen encoded by RNA and formulated in lipid nanoparticles.*"[2] It is highly possible that the mRNA/DNA in the vaccine will combine with the recipient's own DNA and be transmitted to their offspring.[3]

5) COVID shots have not been proven to stop infection or transmission.

COVID shots are technically not a vaccine. Those vaccinated will still be required to mask, physically distance, and avoid large crowds. [4]

6) Coercion is not consent, and is in violation of Canadian Charter Rights and Freedoms and the Nuremberg Code.
